### Updates from members

- 1. Allison Karpyn WIC brief is finished will circulate with members
- 2. Nikko Brady
  - a. Gina, Shebra, and Nikko are merging with Mathematic working on a project that is healthy food retail project
  - b. Nikko, Allison, and Gina are also working on creating a food security toolkit
    - i. To provide a platform of information, recommendations, and tools so governments have a better understanding of food insecurity
  - c. New project going to create a financial assistance program related to food businesses and food supply chains
- 3. Shebra Hall
  - a. Working with American lung association on lung health and improving physical activity Working with youth-serving organizations
  - b. Delaware state
    - i. Mobility clinic and water safety program
      - 1. Families with special needs on water safety and nutrition education
    - ii. Allied health center

  - i. Approved plan University of Delaware (middle school students and healthy retail), Delaware State (elementary schools and nutrition education corners), Food Bank of Delaware (food and early childhood)

- a. Trying to understand how to change current Food Farmacy model to ensure it is culturally relevant
- 6. Presenter Ginnie Sawyer-Morris, University of Delaware Voucher Study
  - a. Fruit and Vegetable Purchases, Consumption, and BMI among Hispanic Farmers' Market Shoppers who use SNAP
  - b. Today's Focus- Farmers Market, SNAP Use, and Hispanic Communities
  - c. Increase in farmers markets, SNAP spending, and SNAP benefits distributed solely to low-income communities
    - i. Representation issue in research Hispanic populations often aren't prioritized
  - d. Hispanic communities experience significant barriers to access SNAP relative to other low-income groups
    - i. Language barriers
    - ii. Fear that SNAP will hurt chances at citizenship
  - e. Little is known about the potentially unique characteristics of Hispanic communities who use SNAP
- 7. Current Study
  - a. Secondary Analysis of baseline data from larger FINI Farmers' Market Study
  - b. Measures
    - i. Demographics
    - ii. FV purchasing
    - iii. FV intake
    - iv. Food insecurity
    - v. BMI
  - c. Goal: Examine between- and within-group differences in FV purchasing, consumption, and BMI among 515 Hispanic and 2,310 non-Hispanic SNAP farmers' market shoppers across 13 states
- 8. Results

a. Hispanic shoppers consumed similar amounts of FV and spent less doing so. Significant subgroup differences were identified for FV purchasing

## 9. Discussion

- a. Hispanic families have larger households and higher food insecurity
- b. Hispanic families demonstrate potentially unique capacity to maintain FV consumption while spending less

# 10. Findings from the literature:

- a. Hispanic families are less likely to apply for SNAP
- b. Hispanic families with lower levels of acculturation (DEFINE) more likely to cook with/consume FV
- c. Household size and food insecurity significantly influence Hispanic families' FV purchasing patterns; association did not exist across other groups

# 11. Implications

- a. Measurement
  - i. Include a write-in option for country of origin
  - ii. Include an acculturation variable
  - iii. Use a resilience lens (positive adaptation despite adversity)
- b. Policy and Practice
  - i. Add additional incentive amount for each person in household
  - ii. SNAP outreach should be culturally responsive
